#### INTERNATIONAL SEO SERVICES AGREEMENT

- 1.2 Services may include, but are not limited to:
  - Technical SEO audit and recommendations
  - On-page optimization (meta tags, headings, content structure)
  - Off-page optimization (link-building strategies, citation management)
  - Content creation and optimization
  - Keyword research and strategy
  - Competitor analysis
  - Monthly performance reporting and analytics
- 1.3 Any additional services beyond the scope of this Agreement require written approval by both Parties.

### 2. Term of Agreement

- 6.1 All content, strategies, or materials created specifically for the Client under this Agreement shall remain the property of the Client upon full payment.

### 7. Confidentiality

- 7.1 Both Parties agree to maintain strict confidentiality regarding any business information, strategies, or sensitive data disclosed during the course of this Agreement.
